

# SSG size diversification report as of market close 6/12/2020:





Company presented – Intelligent Systems (INS) by Steve.

**Buy / sell decisions** –**SELL** all LAD to capture gains, and reduce exposure to autos. Considered buying INS (<\$36), MIDD, GNTX and ULTA. Decided no on GNTX (avoid autos) and ULTA (avoid nonessential consumer goods). **BUY** INS (~\$10,000 @ <\$36/share), put remaining cash in MIDD. Discussion of demand for equipment as restaurants reopen, and for home freezers may lead to increase in high end sales (MIDD's Viking brand).

- Ira presented an interactive online demo "Value Line: Beyond the Reports", an overview of resources available online from Value Line, including weekly updates of ratings for VL stocks.
