



 security's price relative to itself and its past performance, thereby indicating its internal strength. RSI can
 be found in charts from BigCharts.marketwatch.com and other sources. Choose advanced charts, and
 select RSI as the 2nd lower indicator.

- Finance audit was started, but a few items still need to be checked.
