

- o Any notions about how a merger with Constellation Brands would change their outlook?
 - Merger with Constellation would make Monster disappear and it becomes just another part of constellations sales, eps etc.
- Could CBOE be using 45.9% of earnings for dividends as part of a "poison pill" strategy, making the company expensive to take over?
 - That is a possibility, given their type of business, this may be part of that.
- I am confused is the Club just doing a comparison of Bivio versus MylClub? Or is the Club moving to MylClub?
 - As a model club, Yankee does not pay for accounting packages. They are trying to decide whether to change. No decision so far.
 - o What is the conclusion which system is better? and Why?
 - The biggest problem they have hit is the accountsync. It is not as automatic as Bivio's, but that is a choice made by the company.
- o How do you think the merger with Constalleation if it goes through would effect Monster?
 - A merger would make Monster disappear as a company, and if that breaks KO's distribution contract, it might change where you find Monster's drinks.
