

Questions from visitors:

- Is the club concerned with the high market valuations, especially since it's hard to find stocks in the buy range?
 - It has not been yet. As long as the FED continues to pump the economy with cash, the concern would not be great. Sales and Earnings continue to grow at reasonable rates. The club does continue to pay attention to high valuations though. It has sold positions in the past because they were slowing down, not specifically because of the high valuation.
- o What is an Altman-Z?
 - Brent taught a class on Altman-Z a few months ago. You can see the full presentation on YouTube, look for Yankee Model Investment Club. It is a formula designed more than 30 years ago for manufacturing companies.
- Not what BI would consider a quality growth stock.
 - As stated by Liz, when a BI club has a fully developed portfolio, then the club can use a small part, 5-10% of its funds to buy into less BI traditional stocks.
- o How can I get valueline online access and how much would it cost??
 - If you have a local library that supplies online access, you may get that path. I signed up with Fairfax VA library system. The cost is less than \$30 a year and you get access to Morningstar also.
