

- Brent initiated a discussion on how we can ensure cross-training of the members in elected offices, so that other members will be able to take over for these offices in the future. We will continue this discussion and make sure the transition is smooth.
- PERT judgements refreshed with input from members.
- Questions from visitors:
 - What is the reason to lower EPS for the last two years?
 - The approach had to do with differences in the accounting methods used. They
 try to consider GAAP vs non-GAAP and whether the investment income will be
 a continuing source of income. No, please see the bottom of Value Line page
 for adjustments and then the actual EPS value numbers line in the big table
 - Are the modified EPS from Valueline non-GAAP?
 - Value Line generally eliminates what it considers one-time events from the published information. So they would be considered non-GAAP from that perspective. Morningstar lists numbers as published by the company under study. SSG+ is populated with Morningstar.
 - Will Utilities benefit from the propose Infra Bill?
 - I don't know enough of the details. I think utility companies, they are for-profit businesses, pay for their infrastructure themselves, but municipal or other government owned utilities may benefit. As I said, I am uncertain
 - Superior is down
 - As always, Yankee is a long-term investor. We study sales, earnings, etc. and make long term decisions. Short term fluctuations are market emotions, which are important, but not overpowering.
