- Questions from visitors:
 - o 2017 EPS should be adjusted for one-time special item. See value line
 - I assume you are talking about the Media General purchase. We find that type
 of adjustment beyond the scope of this meeting. Trying to explain it to new
 people in the limited time available generally does not work well and the
 adjustment would not appear to alter the outcome on the decision. Also, the
 SSG is prepared using the Morningstar downloaded data rather than Value Line
 data. VL makes adjustments and Morningstar reports raw data.



- No, please see the bottom of Value Line page for adjustments and then the actual EPS value numbers line in the big table
 - Earnings reported at top of VL is \$3.24 + \$6.83 reported at the bottom (non-recurring) is about equal to \$10. reported on the SSG. That is a standard practice for Morningstar and we try not to mix and match information from two different sources.
- In CAGR projection calculations, did you use the sales and EPS numbers in the Value line in year 2024, midpoint of 2024 to 2026 range.
 - Not necessarily. Each partner uses what they prefer. I use VL data to confirm the range of my estimate along with other sources. We try to remember that 5year estimates is like drawing fine lines with crayons, it is only an estimate. Also, VL projects to the nearest \$0.05, which is not complete precision.
- How would one go about determining whether Nexstar's debt is fixed or variable rate?
 - Typically, you go to the annual or quarterly report called a 10-K or 10-Q for such info. Recently more companies have provided much of that info on the company website.
