

- Questions from visitors:
 - What tool is being used to do this review and evaluation?
 - So far he has used the bivio website, the accounting program Yankee uses.
 Bivio is an annual fee based service (\$179, I think).
 - Some members are using desktop version of the Toolkit6 program
 - Others use the online version of SSG. The BetterInvesting website is available to members and access to SSGPlus for basic member. The PERT is available on the BetterInvesting website for members. It costs something like \$45 annually to be a member which gets you base exposure. The SSGPlus membership costs an additional amount, maybe \$75 or \$85 annually. These are individual expenses that each partner commits to spend annually.
 - How do you set your goals for the club and how often do you do that?
 - The club has an overall policy statement which is reviewed annually but rarely modified. Targets for each company holding are reviewed monthly, this will occur later in the meeting.
 - o Do you have to subscribe to MyStockProspector to do the screen?
 - The screen used was from the BI monthly email. They just use MyStockProspector as the source.
 - Is a company defined as small cap by its sales? If so, what is the sales range of a small cap company?
 - It varies by source; however, generally sales up to \$1 billion is small, \$1 billion to \$10 billion is medium and above \$10 billion is large
