

- I have several stock positions I'd like to sell in this volatile market. How can I use Trailing Stop Loss and/ or Trailing Stop Limit to track the stock moving up and sell when there is a material drop in price.
 - It depends on your broker. Some allow such action to be automated in the account. On the infrequent times that I has used stops, I set a percentage drop from the current or trailing stop. BetterInvesting does not teach the use of stops.
- o Is it necessary to set up a margin account in order to write options?
 - No. One of Joe's clubs occasionally trades covered calls and does not have a margin account. In addition, as Ira noted, doing covered calls is permissible in an IRA and IRAs cannot be a margin account. Marc, it is necessary to get option privileges from the brokerage.
- I'm interested in starting a family investment club, but not all family members live in the same state. What are the tax concerns if club members live in different states? If formed, the club would be registered in Montana.
 - This is a very broad question. Each state has different requirements for out of state partners in partnership. Your best bet is to contact ICLUBCentral.com help desk and they may be able to answer the question. I live in MS, and members of the model club live in MA, CA, CT and TX. The model club as a matter of practice only will take in members in states that do not require the club to file an out of state tax return.
- Does anybody do technical analysis on cultural phenomena such as the effect of popular songs?
 - Interesting thought, I've never heard anyone talk about that angle.
