

Stock Study Presentation – Ira presented the SSG analysis for HLI Holdings, Inc. (HLI) and he recommended purchase of this stock. Club members discussed and presented their input on the discussion.

Review of Stock Portfolio: Members presented their updates for stocks they were watching. Jack presented the Bivio Valuation Report during the individual presentations. Sriram also presented the Manifest Investing Summary and the BetterInvesting PERT. After individual presentations, club members discussed status of all the holdings.

Watchlist update: No specific recommendations from the updated watch list discussions GNTX (3/13/21), LRN (5/8/21), NXST (6/12/2021), AQN (9/11/2021) and IBP (2/12/2022). No changes.

Buy/Sell decisions –

SELL: All Regeneron Pharmaceuticals (REGN) and all FleetCor Technologies (FLT)

BUY: Use current cash and proceedings from selling FLT and REGN to buy HLI and increase holdings in YETI, MBUU and MKSI, to keep them at similar levels.

General club business:

Old: Portfolio challenge. YMIC is doing well – being placed at #1 in the rankings.



New: Update to the meeting structure in the procedures

• Questions from visitors –

- How does one interpret Altman -Z score what is a threshold /indicator
 - It is a measure of potential for a company is headed for bankruptcy. A value greater than 3 indicates the company will not go bankrupt.
- o What does Morning star Fair price mean is it a good price to buy?
 - The Morningstar Fair Value Estimate tells investors what the long-term intrinsic value of a stock is, helping them see beyond the present market price.
 Morningstar calculates the fair value estimate of a company based on how much cash they think the company will generate in the future.
 - Any price below the fair value is expected to do better
- Please explain the distinction(s) between semiconductor "companies" and "foundries."
 A semiconductor company that makes chips for others companies is a foundry.
- Interest rates have been going up. Started in March and the next fed meeting is this week including projections.
 - YMC pays some attention to interest rates, but just as inflation is presenting problems the partners consider these issues in their analysis.
