
Treasurer's Report – Ira presented the treasurer's report for October 2023, and they were accepted as presented.

Stock Study Presentation – Brent presented the SSG for the EXL Services (EXLS) and provided a thorough analysis of the stock, an overview of the company and how it is positioned for future. It was well received and the members provided their own analyses of the company.

Review of Stock Portfolio: Members presented their updates for stocks they were watching. Ira showed the Bivio Valuation Report during the individual presentations. After individual presentations, club members discussed status of all holdings.

Sriram presented the expanded PERT chart, with more analysis. Using the template that Joe developed, the detailed analysis PERT spreadsheet helped in identifying general trends and provide a better picture to discuss.

Watchlist update: No discussion of the watchlist stocks, as Jack was absent.

Backburner List: No discussion.

Buy/Sell decisions – After discussion, the club decided to make the following trades:

SELL: 100% of Inmode, and about 25% of D.R. Horton

BUY: Purchase EXLS with the sale of DR Horton and available cash. Save the proceedings of Inmode for future purchases.

- OLC Portfolio challenge: We selected HIFS, CHGG, PLNT and ENPH for Online Chapter 2023-2024 Stock Picking Contest. Jack submitted the official entry for the club. Sriram was not able to find the status during the meeting, but since we are at the bottom of the list of five entries. Our portfolio is losing about 18%
- GoToWebinar max meeting limit Since Joe thinned the registration list a few months ago, it has grown to 174 names who have attended within the last year. This will make it easier to manually transfer the registration list in December to start a new set of 50 monthly meeting invitations, as we are reaching the limit (47 through December).

New:

 Renew club membership with BetterInvesting. Brent will distribute the renewal form with costs and choices to each member. Members should write a check to BetterInvesting and send it to Sriram (or Venmo it to Jack).

Questions from visitors – Mostly answered by Joe in the back room.

- What is PAR on the Manifest investing?
 - Projected Annual Return is the sum of forecast price appreciation (annualized) and the projected dividend yield
- Why not consider selling all the losers and investing in your winners?
 - As you know, unfortunately those that are losers frequently become winners and winners do occasionally become losers. The BI program suggests that we identify companies with good fundamentals and stay with them through temporary rough spots. Sell when the fundamentals decline over longer term or when the basis for purchase no longer exist. We are after all longer term holders in general.
