

Stock Study Presentation – Sriram presented an SSG for Paycom Software, Inc. (PAYC) and provided a thorough analysis of the stock, an overview of the company and how it is positioned for the future. Steve pointed out that there are a lot of lawsuits over how PAYC handled their new BETI product. (Some BETI sales came at the expense of other PAYC products which led to reduced sales overall, and a drop in stock price). In the end, Sriram recommended we NOT buy PAYC.

Review of Stock Portfolio: Members presented their updates for stocks they were watching. Ira showed the Bivio Valuation Report during the individual presentations. After individual presentations, club members discussed status of all holdings.

Sriram showed the dashboard for the portfolio from Manifest investing.

Watchlist update: No discussion of the watchlist stocks. Item for discussion at next meeting: remove stocks that have aged out. Add GNTX?

Backburner List: No discussion.

Buy/Sell decisions – After discussion, the club decided to make no changes in the portfolio. The club should consider small companies (< \$1B annual sales) for the next six months or so to get a better balance in the portfolio.



General club business:

Old:

OLC Portfolio challenge: We 'invested' \$25,000 (virtually) each in HIFS, CHGG, PLNT and ENPH for the Online Chapter 2023-2024 Stock Picking Contest. We are up 3.8% so far, which puts us fifth (out of 6) in the contest. The leader is up 14.2%. The link for the contest is:

New:

- Remove 'stale' stocks on the list, with SSGs older than 1 year.
 - Remove ASML, IBP, and OLED
 - Add GNTX, PAYC and PAYX

Questions from visitors – Mostly answered by Joe in the back room.

- PAYC discussion:
 - Do they compete with PAYX?
 - Yes, plus ADP and others.
 - The pretax profit is increasing, so maybe EPS should be higher.
 - PTP is recovering after a dip from 30% to 22%. EPS is growing at about 35% in the most recent TTM.
 - Here's the CEO comment in earnings call in 2023Q3: "Now that more clients are achieving the ROI that Beti has to offer, it has eliminated certain billable items, which is cannibalizing a portion of our services and unscheduled revenues."
 - Might be a good idea to add to the "Notes" on PAYC SSG the lawsuit stuff.
 - I'll suggest it to them. Joe
 - Nice discussion on PAYC ...
- Can anyone present a stock to the club? Or is some designated in the club to present potential stocks to invest in?
 - Each partner does the lead presentation in rotation month to month. Every partner is informed in advance what stock will be presented so the other partners can also study the company in advance. One of the things a potential new member must do is provide a stock presentation much like you have seen today. One of the current partners acts as a tutor/mentor for that new person. Both of the ladies and one of the men are relatively new partners. I hope this is responsive to your question Joe
 - Yes. Thank you.
- NextEra's (NEP) price has really come down in the \$60's with a 3% yield.
 - They and their companion company, NEE, are having some finance problems if I remember correctly.
