- 1) The meeting was called to order by JH at 7:07pm. He welcomed prospective members Mike Shearer and David Harvick.
 - 2) The secretary stated that there were no minutes of the previous meetings available for approval.
 - 3) RJ displayed the Treasurers Report using the Bivio website and stated that the Bivio website is available to all partners to view all BMI documents.
 - 4) All members in attendance paid their respective minimum \$50 monthly contribution. Total receipt \$590.00.
 - 5) **Motion by RJ to Transfer \$1000 to the First Trade account considering that \$ 590 was received this meeting.** Second by AP. The motion carried by unanimous vote.
 - 6) **Stock Study Segment:** JH circulated Stock Check List & Stock Selection Guide for Cognizant Tech Solutions (NASDAQ "CTSH"). Review of the stock data and discussions followed.
 - 7) **Motion by RJ to buy Cognizant (CTSH).** Second by AP. The motion to buy Cognizant (CTSH) received a unanimous vote.
 - 8) **Motion by HB for BMI to buy 50 shares of CTSH (Current price \$31.19).** Second by AP. A discussion followed regarding how many shares to purchase considering current brokerage account balance. **The motion Failed based on a 4 For & 5 Against vote of the partners.**
 - 9) **Motion by RJ to buy 40 shares of CTSH.** Second by HB. The motion carried by a 6 For & 3 Against vote of the partners.
 - 10) A discussion about the setting of a buy price **LIMIT** when executing an On-Line trade followed the vote to purchase 40 shares of CTSH.
 - 11) **Motion by JH to set a Limit of \$40.00 per share on the purchase of CTSH.** Second by RJ. The motion was approved by unanimous consent.
