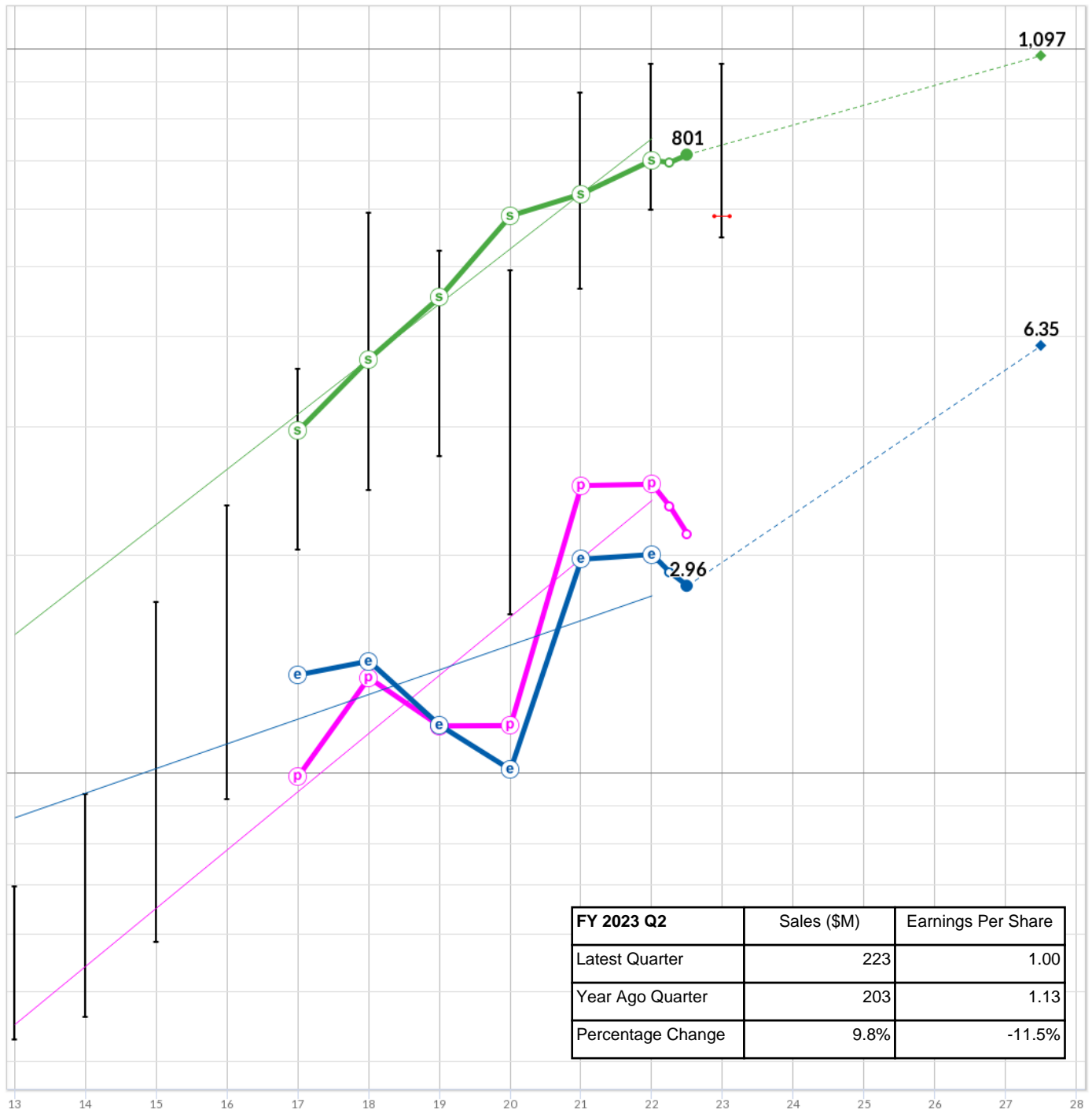

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 30.0 X Estimate High Earnings/Share 6.35 = Forecasted High Price \$ 190.5

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 25.0 X Estimate Low Earnings/Share 2.96 = Forecasted Low Price \$ 74.0

(b) Avg. Low Price of Last 5 Years 57.0

(c) Recent Market Low Price 75.9

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{190.5 - 95.80}{95.80 - 74.0} = \frac{94.70}{21.80} = 4.3$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{190.5 - 95.80}{95.80} = 1.9885 \times 100 = 198.85 - 100 = 98.9$ % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{0.00}{95.80} = 0.0000 = 0.0\%$ Current Yield

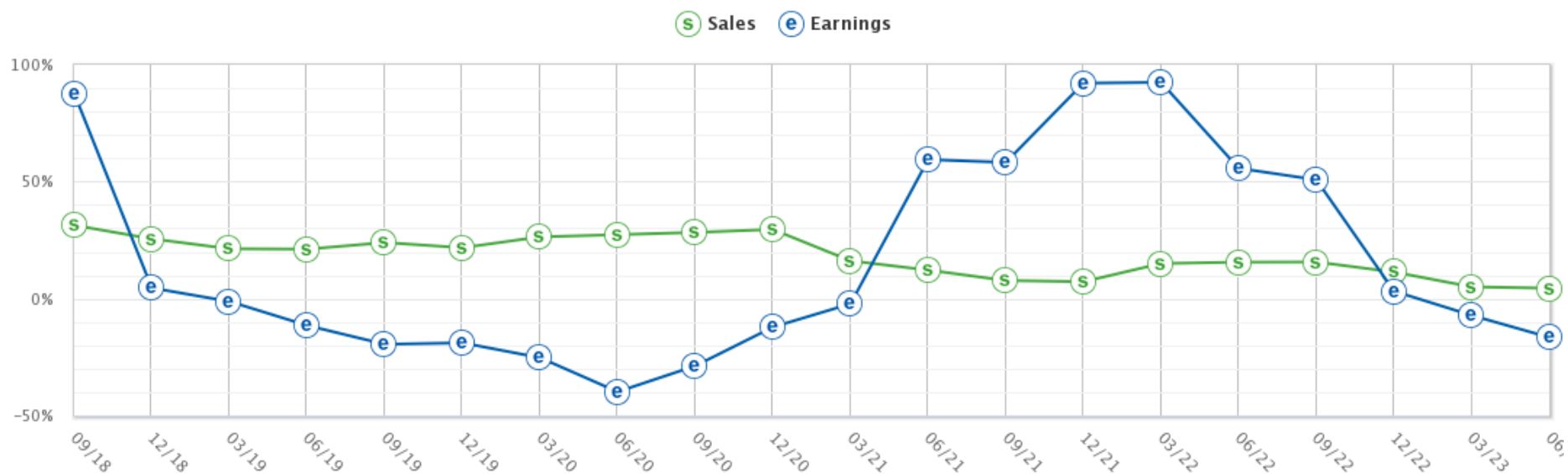
