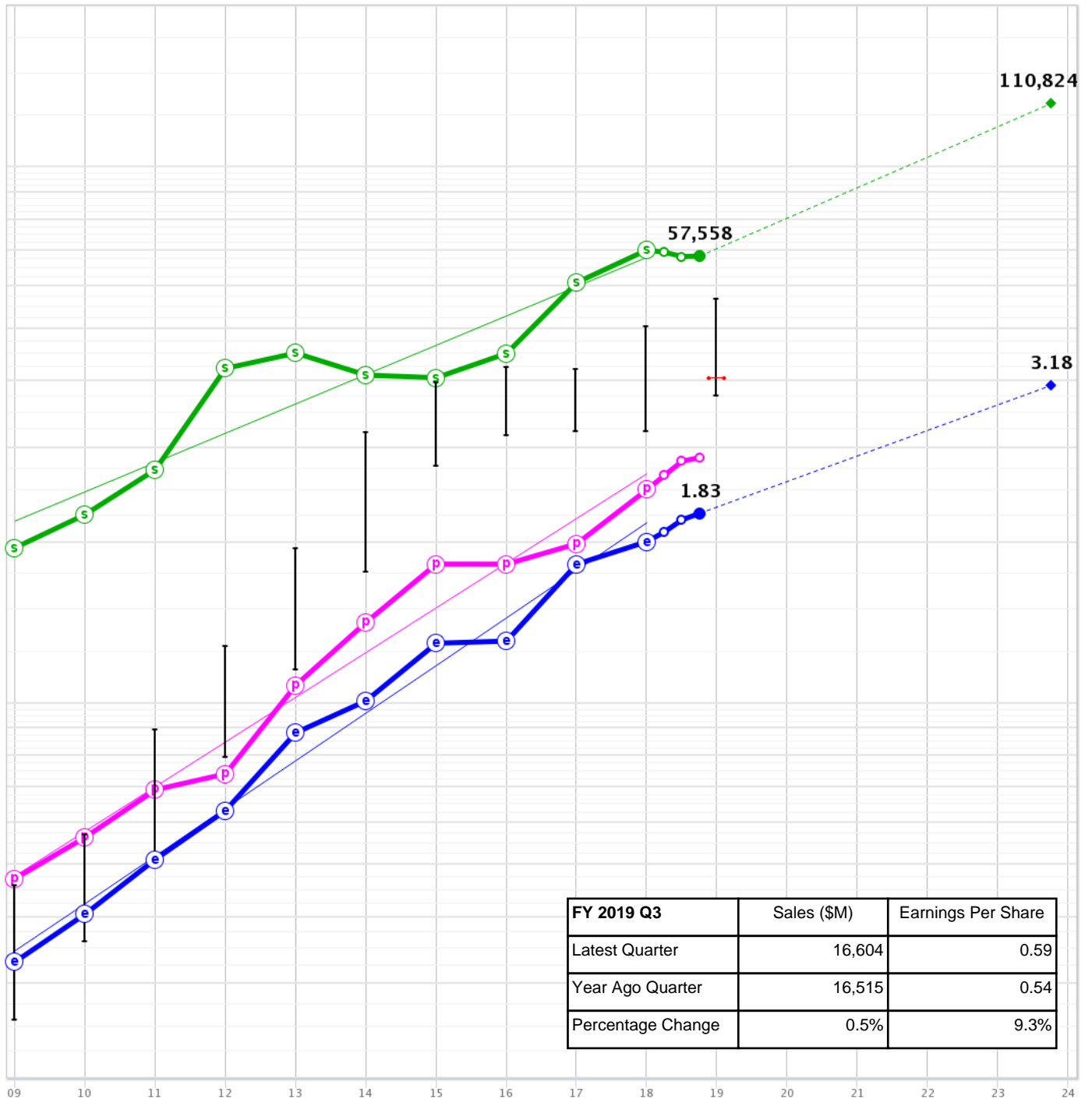

## 4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

### A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 25.0 X Estimate High Earnings/Share 3.18 = Forecasted High Price \$ 79.5

### B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 19.3 X Estimate Low Earnings/Share 1.83 = Forecasted Low Price \$ 35.3

(b) Avg. Low Price of Last 5 Years 22.9

(c) Recent Market Low Price 26.0

(d) Price Dividend Will Support  $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{0.28}{0.62\%} = 45.0$

Selected Forecasted Low Price \$ 22.9

### C ZONING using 33%-33%-33%

Forecasted High Price 79.5 Minus Forecasted Low Price 22.9 = 56.6 Range. 33% of Range 18.9

Buy Zone 22.9 to 41.7

Hold Zone 41.7 to 60.6

Sell Zone 60.6 to 79.5

Present Market Price of 32.84 is in the **BUY** Zone

### D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price}} = \frac{79.5 - 32.84}{32.84} = 4.7$   
 $\frac{\text{Present Price} - \text{Low Price}}{\text{Present Price}} = \frac{32.84 - 22.9}{32.84} = 0.3$   
 Ratio = 4.7 To 1

### E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{79.5 - 32.84}{32.84} = 2.4208$   
 $2.4208 \times 100 = 242.08 - 100 = 142.1\%$  % Appreciation

## 5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

**A**  $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{0.16}{32.84} = 0.0085 = 0.9\%$  Current Yield

### B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{9.9\%}{25.00} = 0.4\%$

### AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{9.9\%}{22.15} = 0.4\%$

### C COMPOUND ANNUAL RETURN - USING FORECAST HIGH P/E

Annualized Appreciation 19.3 %  
 Average Yield 0.4 %  
 Annualized Rate of Return 19.7 %

### COMPOUND ANNUAL RETURN - USING FORECAST AVG P/E

Annualized Appreciation 16.5 %  
 Average Yield 0.4 %  
 Annualized Rate of Return 16.9 %
