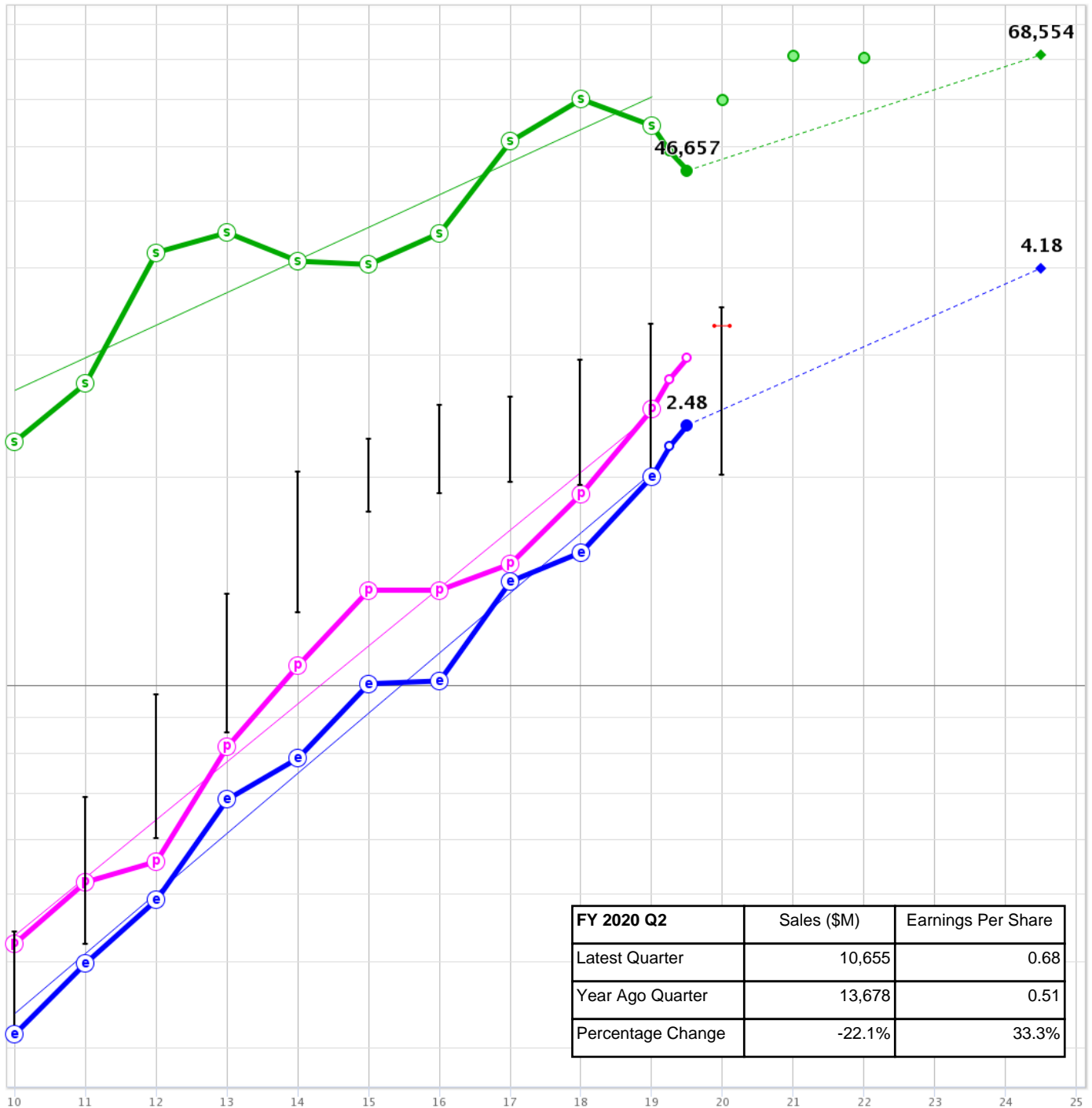

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 18.0 X Estimate High Earnings/Share 4.18 = Forecasted High Price \$ 75.2

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 12.0 X Estimate Low Earnings/Share 2.48 = Forecasted Low Price \$ 29.8

(b) Avg. Low Price of Last 5 Years 20.0

(c) Recent Market Low Price 20.3

(d) Price Dividend Will Support $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{0.27}{0.91\%} = 29.9$

Selected Forecasted Low Price \$ 29.8

C ZONING using 25%-50%-25%

Forecasted High Price 75.2 Minus Forecasted Low Price 29.8 = 45.4 Range. 25% of Range 11.4

Buy Zone 29.8 to 41.2

Hold Zone 41.2 to 63.9

Sell Zone 63.9 to 75.2

Present Market Price of 34.47 is in the **BUY** Zone

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price}} = \frac{75.2 - 34.47}{34.47} = 1.1822$
 $\frac{\text{Present Price} - \text{Low Price}}{\text{Present Price}} = \frac{34.47 - 29.8}{34.47} = 0.1364$
 Ratio = $\frac{1.1822}{0.1364} = 8.7$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{75.2 - 34.47}{34.47} = 2.1822$
 $2.1822 \times 100 = 218.22 - 100 = 118.2\%$ % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{0.19}{34.47} = 0.0079 = 0.8\%$ Current Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{9.9\%}{18.00} = 0.6\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{9.9\%}{15.00} = 0.7\%$
