4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 30.0 X Estimate High Earnings/Share 50.86 = Forecasted High Price \$ 1,525.8

B LOW PRICE - NEXT 5 YEARS

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price } 1,525.8 - \text{Minus Present Price } 1,042.68}{\text{Present Price } 1,042.68 - \text{Minus Low Price } 833.0} = \frac{483.10}{209.68} = 2.3$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price } 1,525.8 - \text{Closing Price } 1,042.68}{\text{Closing Price } 1,042.68} = 1.4633 \times 100 = 146.33 - 100 = 46.3$ % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.
