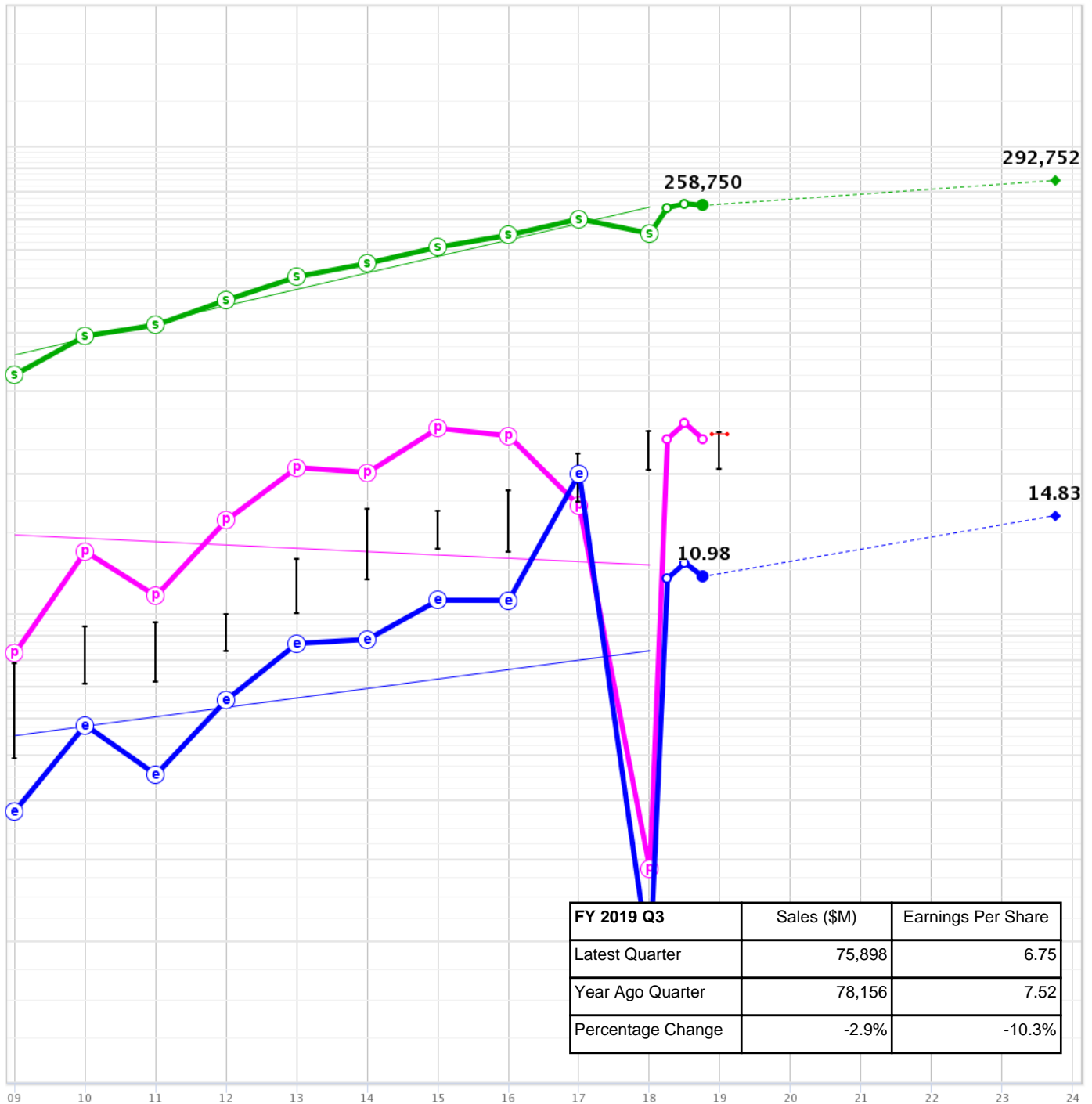

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 17.2 X Estimate High Earnings/Share 14.83 = Forecasted High Price \$ 255.0

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 13.0 X Estimate Low Earnings/Share 10.98 = Forecasted Low Price \$ 142.7

(b) Avg. Low Price of Last 5 Years 140.1

(c) Recent Market Low Price 158.6

(d) Price Dividend Will Support $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{0.00}{0.00\%} = 0.0$

C ZONING using 25%-50%-25%

Forecasted High Price 255.0 Minus Forecasted Low Price 177.0 = 78.0 Range. 25% of Range 19.5

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price}} = \frac{255.0 - 221.38}{221.38} = \frac{33.63}{221.38} = 0.152$
 $\frac{\text{Present Price} - \text{Low Price}}{\text{Present Price}} = \frac{221.38 - 177.0}{221.38} = \frac{44.38}{221.38} = 0.200$
 Ratio = 0.152 / 0.200 = 0.76 To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{255.0 - 221.38}{221.38} = 0.152$
 $0.152 \times 100 = 15.2\%$ % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{0.00}{221.38} = 0.0000 = 0.0\%$ Current Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{0.0\%}{17.20} = 0.0\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{0.0\%}{15.10} = 0.0\%$
