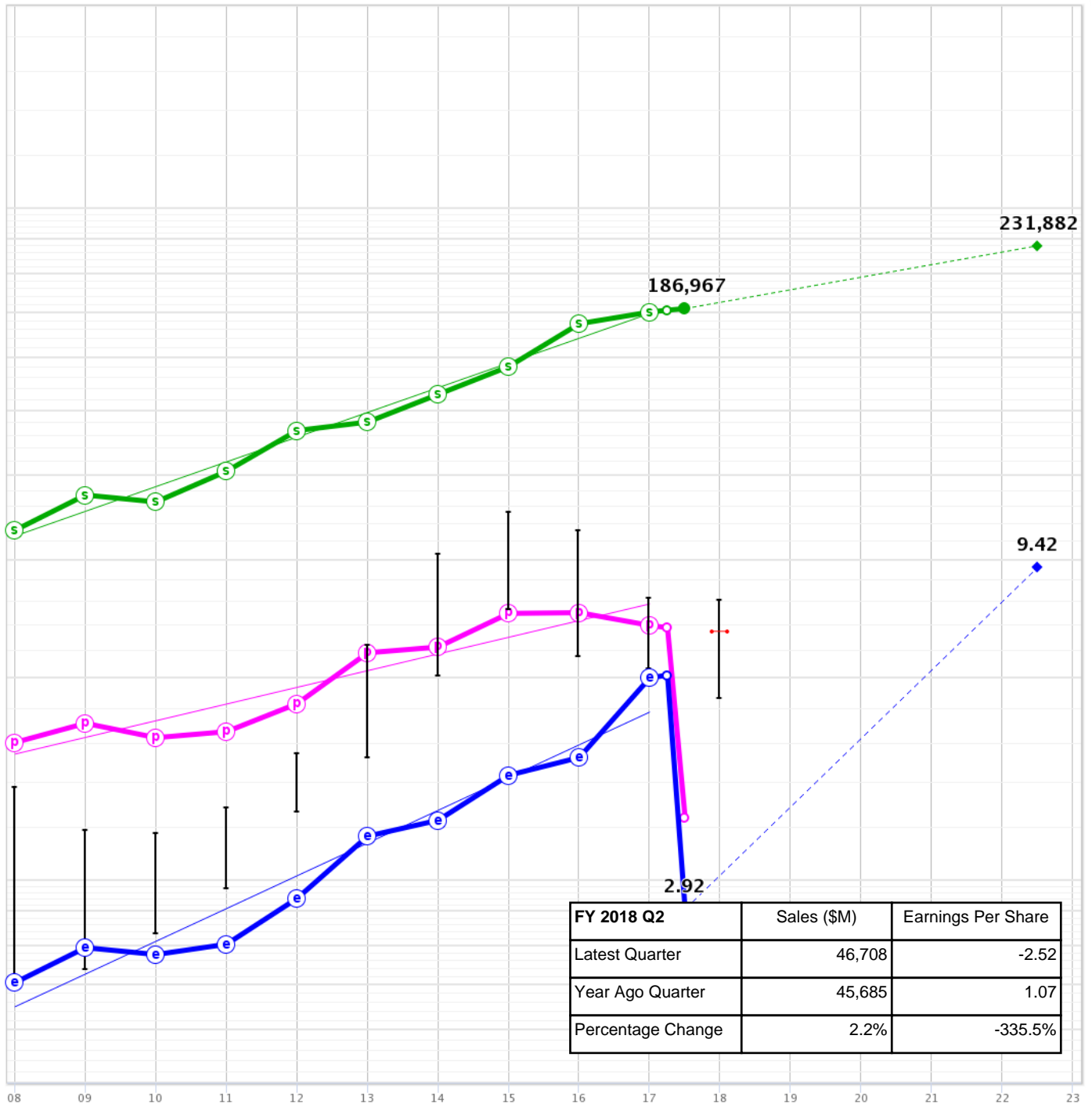

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 14.0 X Estimate High Earnings/Share 9.42 = Forecasted High Price \$ 131.9

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 14.3 X Estimate Low Earnings/Share 6.45 = Forecasted Low Price \$ 92.2

(b) Avg. Low Price of Last 5 Years 66.2

(c) Recent Market Low Price 60.1

(d) Price Dividend Will Support $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{2.00}{3.01\%} = 66.4$

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{131.9 - 75.64}{75.64 - 60.0} = \frac{56.26}{15.64} = 3.6$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price}}{\text{Closing Price}} = \frac{131.9}{75.64} = 1.7438$ X 100 = 174.38 - 100 = 74.4 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{2.00}{75.64} = 0.0264 = 2.6\%$ Current Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{29.5\%}{14.00} = 2.1\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{29.5\%}{14.15} = 2.1\%$

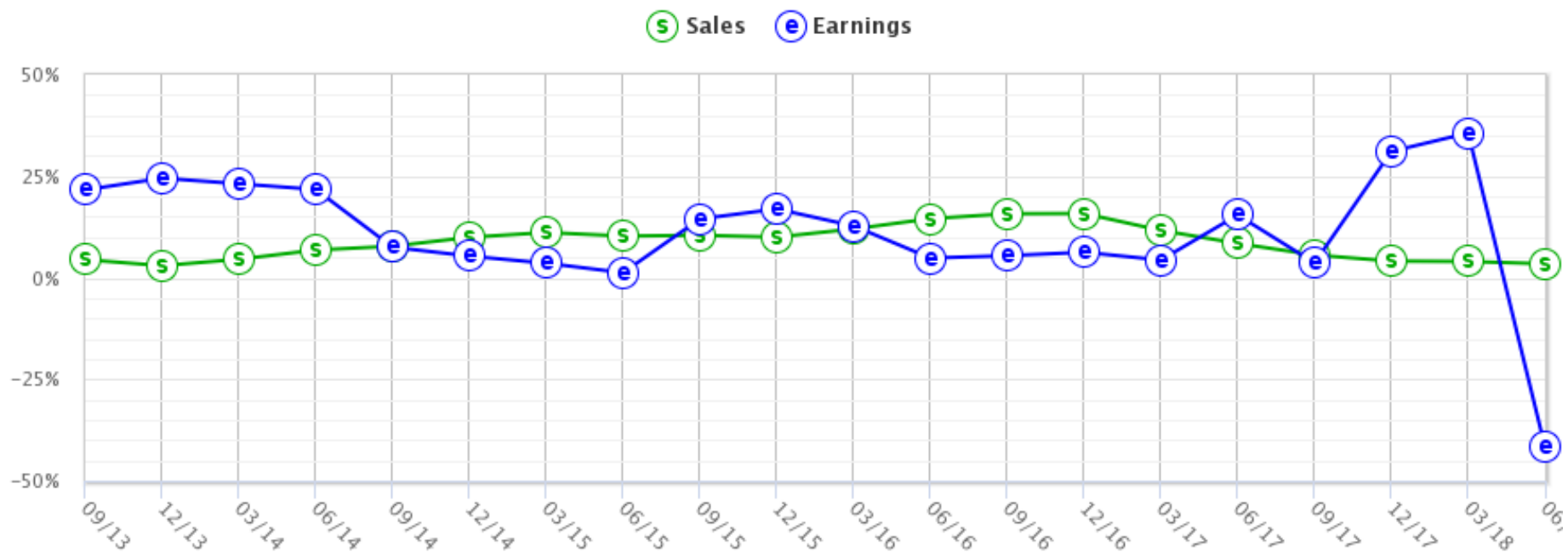
