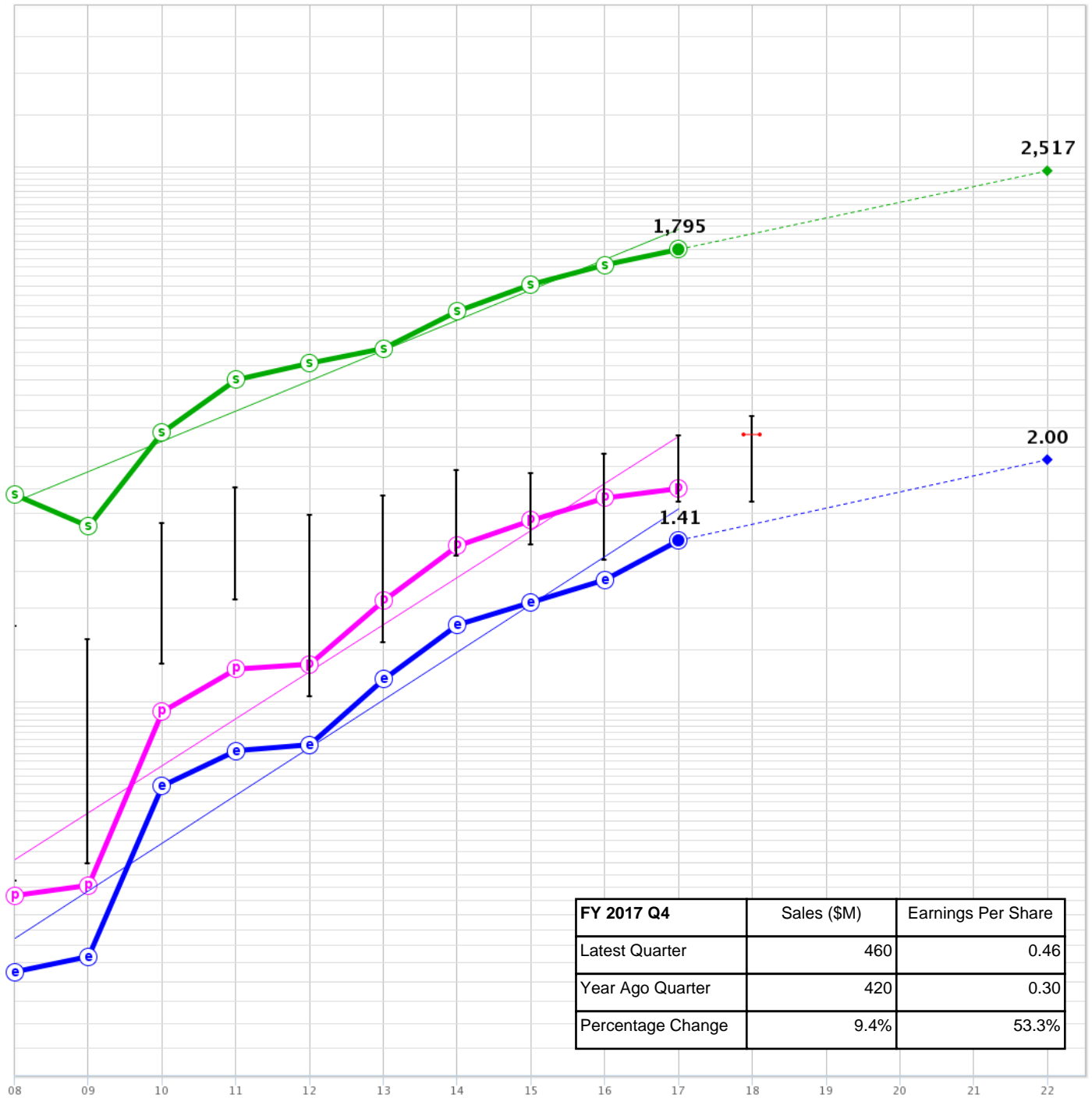

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 15.2 X Estimate High Earnings/Share 2.00 = Forecasted High Price \$ 30.3

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 15.2 X Estimate Low Earnings/Share 1.41 = Forecasted Low Price \$ 21.4

(b) Avg. Low Price of Last 5 Years 13.1

(c) Recent Market Low Price 12.9

(d) Price Dividend Will Support $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{0.40}{3.09\%} = 12.9$

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{30.3 - 22.24}{22.24 - 21.4} = \frac{8.10}{0.84} = 9.6$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{30.3 - 22.24}{22.24} = 1.3643$ X 100 = 136.43 - 100 = 36.4 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{0.39}{22.24} = 0.0180 = 1.8\%$ Current Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{31.3\%}{15.20} = 2.1\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{31.3\%}{15.20} = 2.1\%$

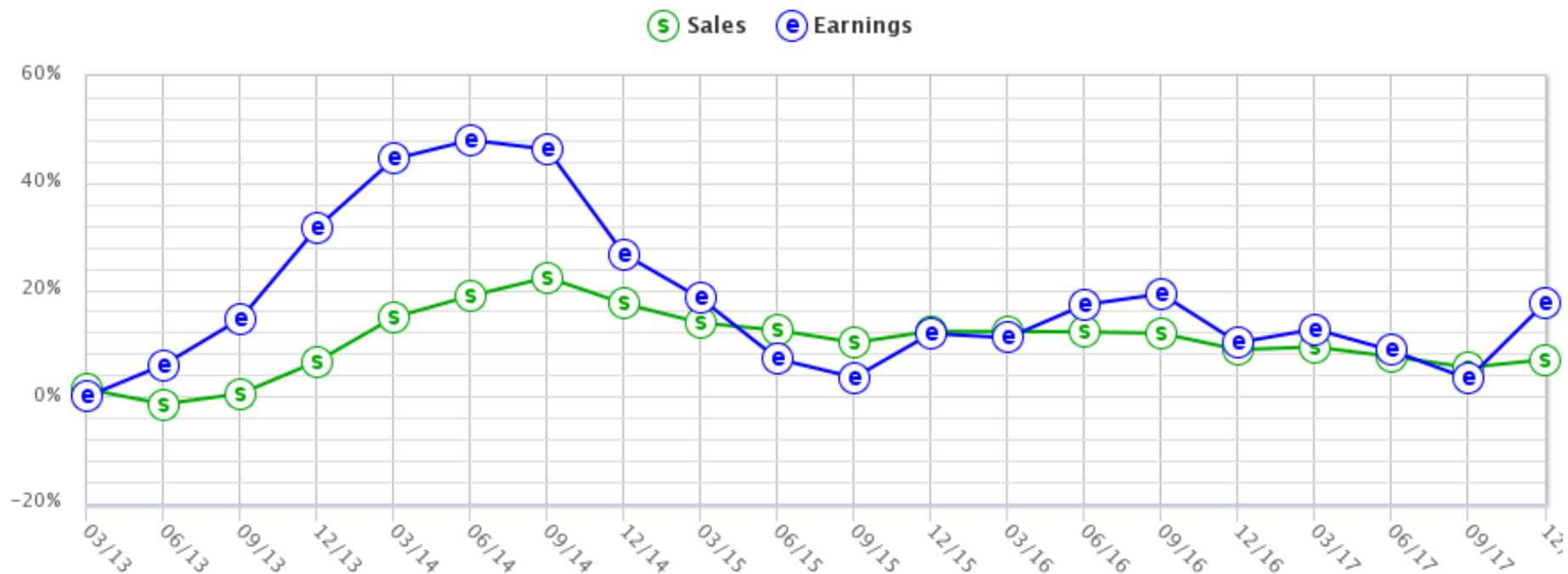
