4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 10.8 X Estimate High Earnings/Share 9.65 = Forecasted High Price \$ 104.2

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 9.5 X Estimate Low Earnings/Share 7.59 = Forecasted Low Price \$ 72.1

(b) Avg. Low Price of Last 5 Years 74.2

(c) Recent Market Low Price 66.6

(d) Price Dividend Will Support $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{2.70}{3.13\%} = 86.2$

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{104.2 - 84.47}{84.47 - 66.5} = \frac{19.71}{17.97} = 1.1$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{104.2 - 84.47}{84.47} = 1.2334$ X 100 = 123.34 - 100 = 23.3 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{2.70}{84.47} = 0.0346 = 3.5\%$ Current Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{28.3\%}{10.80} = 2.6\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{28.3\%}{10.15} = 2.8\%$
