

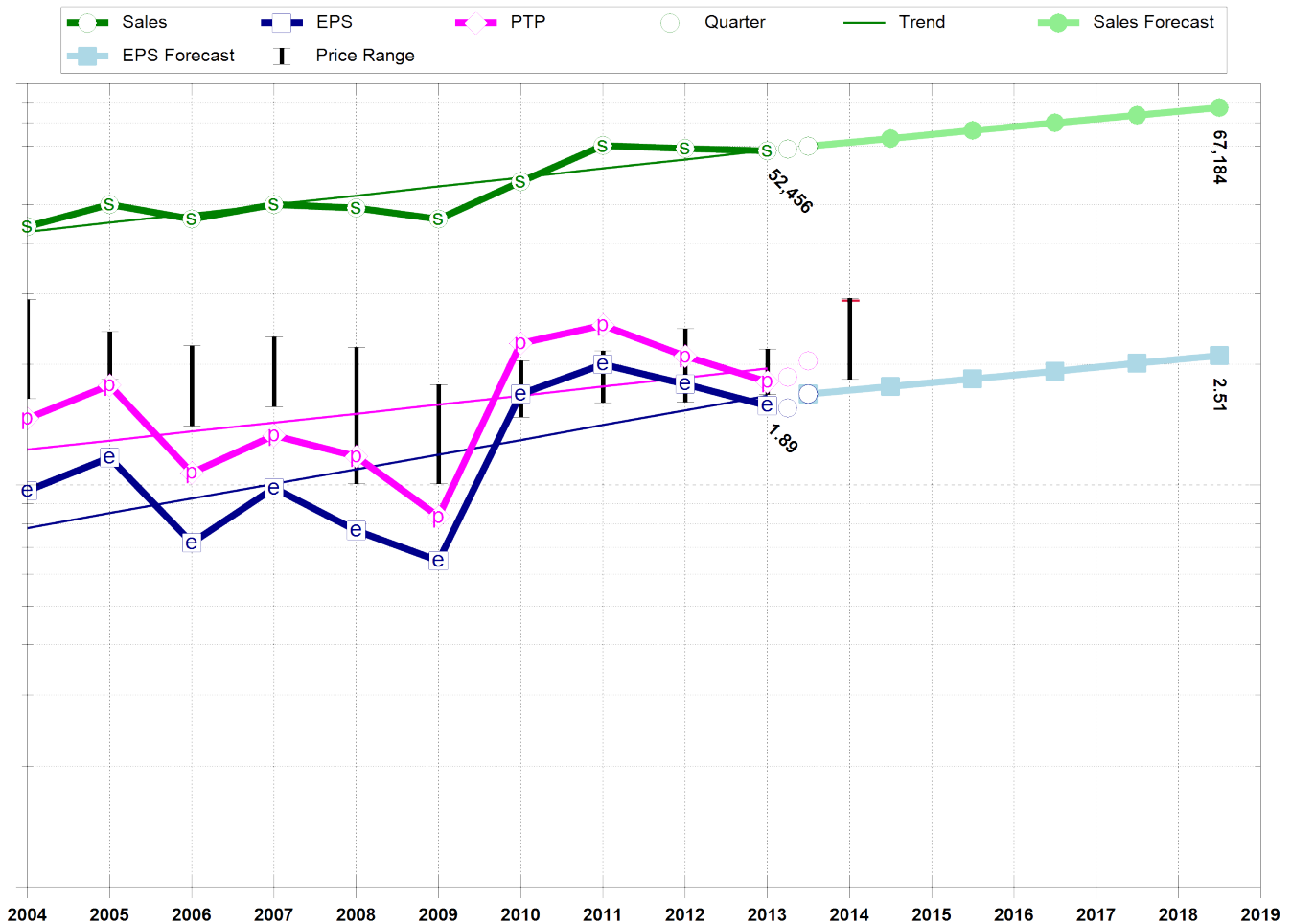

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 17.00 X Estimate High Earnings/Share 2.51 = Forecasted High Price \$ 42.7

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 12.00 X Estimate Low Earnings/Share 1.89 = Forecasted Low Price \$ 22.7

(b) Avg. Low Price of Last 5 Years 17.6

(c) Recent Market Low Price 19.23

(d) Price Dividend Will Support $\frac{\text{Present Dividend}}{\text{High Yield}} = \frac{0.900}{4.50\%} = 20.0$

Selected Forecasted Low Price \$ 27.0

C ZONING using 25%-50%-25%

Forecasted High Price 42.7 Minus Forecasted Low Price 27.0 = 15.7 Range. 25% of Range 3.9

Buy Zone 27.0 to 30.9

Hold Zone 30.9 to 38.8

Sell Zone 38.8 to 42.7

Present Market Price of 34.41 is in the **Hold** Zone

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{42.7 - 34.41}{34.41 - 27.0} = \frac{8.26}{7.41} = 1.1$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price}}{\text{Present Market Price}} = \frac{42.7}{34.41} = 1.24$ X 100 = 124.00 - 100 = 24.0 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Present Full Year's Dividend \$}}{\text{Present Price of Stock}} = \frac{0.90}{34.41} = 0.03 = 2.6\%$ Present Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{45.0\%}{17.00} = 2.6\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{45.0\%}{14.50} = 3.1\%$

C COMPOUND ANNUAL RETURN - USING FORECAST HIGH P/E
