

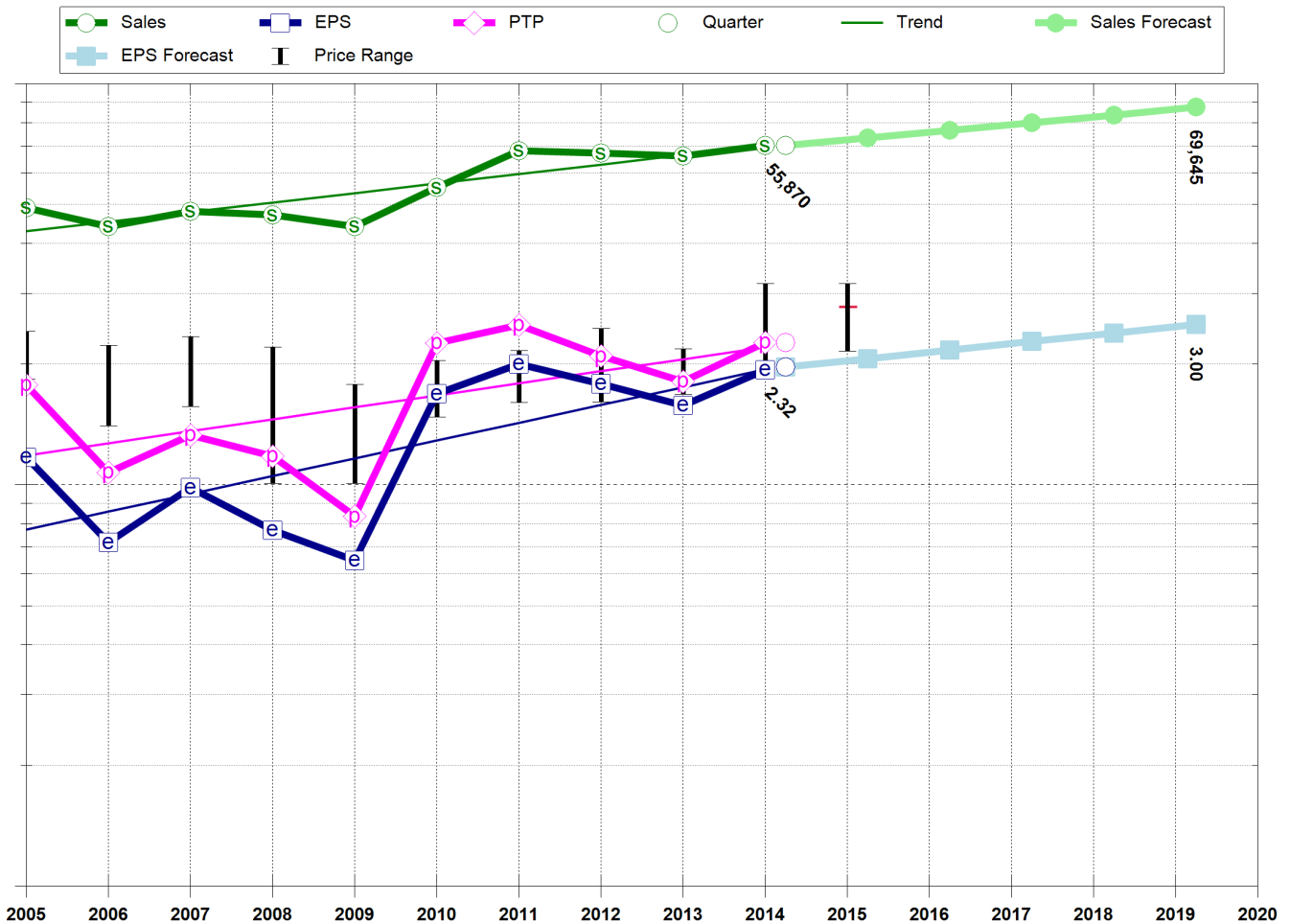

## 4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

### A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 17.00 X Estimate High Earnings/Share 3.00 = Forecasted High Price \$ 51.0

### B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 10.50 X Estimate Low Earnings/Share 2.35 = Forecasted Low Price \$ 24.7

(b) Avg. Low Price of Last 5 Years 19.9

(c) Recent Market Low Price 20.10

(d) Price Dividend Will Support  $\frac{\text{Present Dividend}}{\text{High Yield}} = \frac{0.960}{3.80\%} = 25.3$

Selected Forecasted Low Price \$ 24.7

### C ZONING using 25%-50%-25%

Forecasted High Price 51.0 Minus Forecasted Low Price 24.7 = 26.3 Range. 25% of Range 6.6

Buy Zone 24.7 to 31.3

Hold Zone 31.3 to 44.4

Sell Zone 44.4 to 51.0

Present Market Price of 33.15 is in the **Hold** Zone

### D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{51.0 - 33.15}{33.15 - 24.7} = \frac{17.85}{8.45} = 2.1$  To 1

### E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price}}{\text{Present Market Price}} = \frac{51.0}{33.15} = 1.54$  X 100 = 153.85 - 100 = 53.8 % Appreciation

## 5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A  $\frac{\text{Present Full Year's Dividend \$}}{\text{Present Price of Stock}} = \frac{0.96}{33.15} = 0.03 = 2.9\%$  Present Yield

### B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{38.3\%}{17.00} = 2.3\%$

### AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{38.3\%}{13.75} = 2.8\%$

### C COMPOUND ANNUAL RETURN - USING FORECAST HIGH P/E

Annualized Appreciation 9.0 %  
Average Yield 2.3 %  
Annualized Rate of Return 11.2 %

### COMPOUND ANNUAL RETURN - USING FORECAST AVG P/E

Annualized Appreciation 4.5 %  
Average Yield 2.8 %  
Annualized Rate of Return 7.3 %
