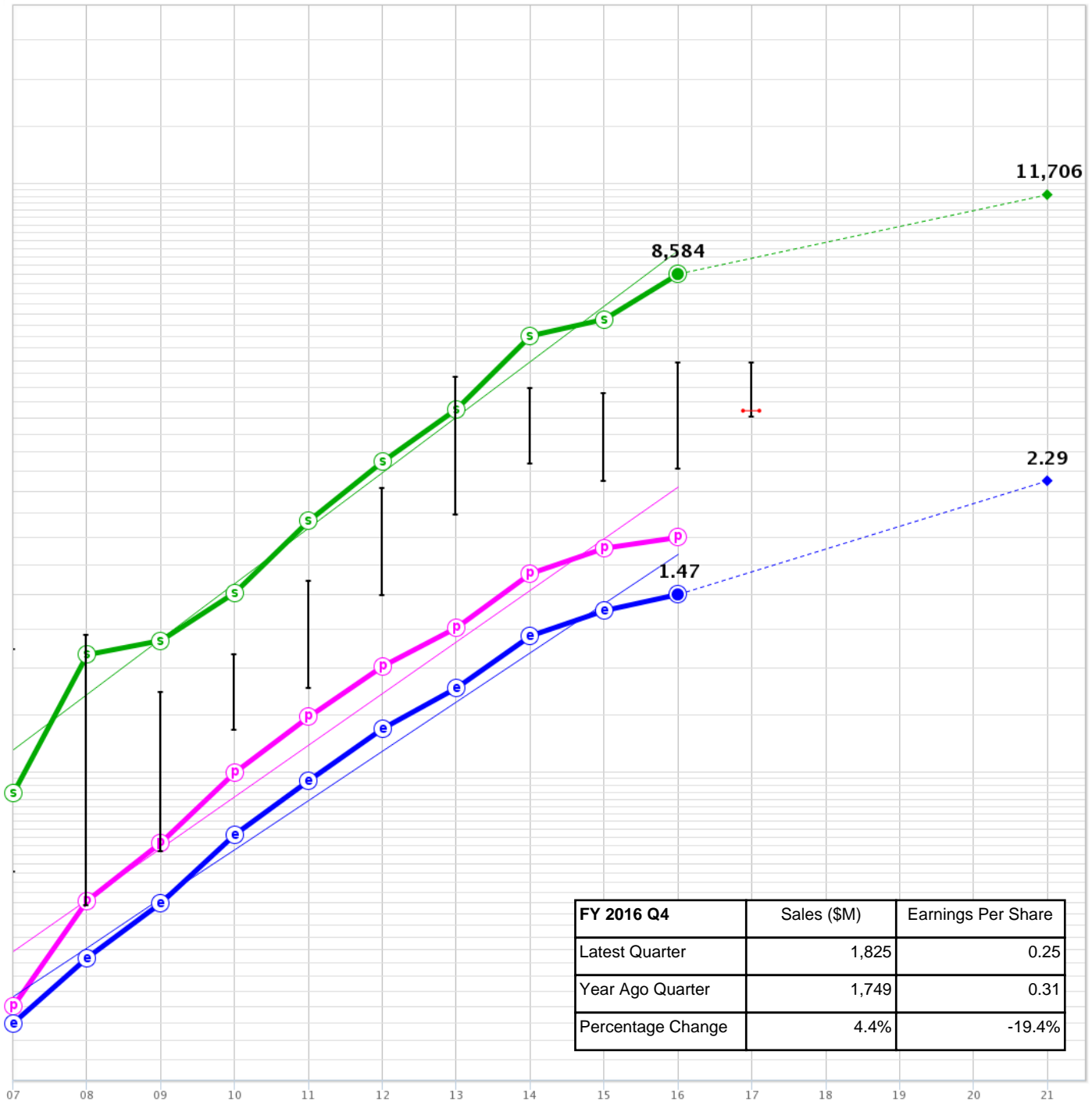

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 22.2 X Estimate High Earnings/Share 2.29 = Forecasted High Price \$ 50.9

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 17.3 X Estimate Low Earnings/Share 1.47 = Forecasted Low Price \$ 25.4

(b) Avg. Low Price of Last 5 Years 21.2

(c) Recent Market Low Price 22.9

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{50.9 - 30.15}{30.15 - 24.1} = \frac{20.76}{6.05} = 3.4$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{50.9 - 30.15}{30.15} = 1.6884$ X 100 = 168.84 - 100 = 68.8 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

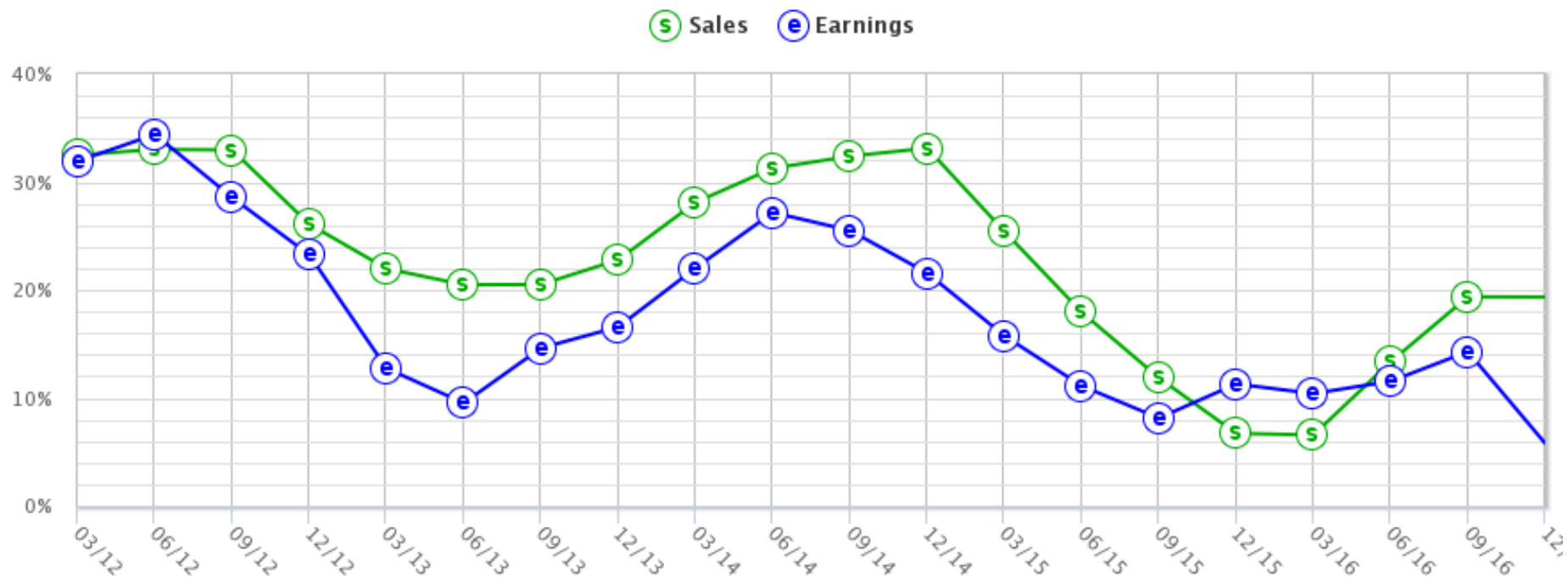
