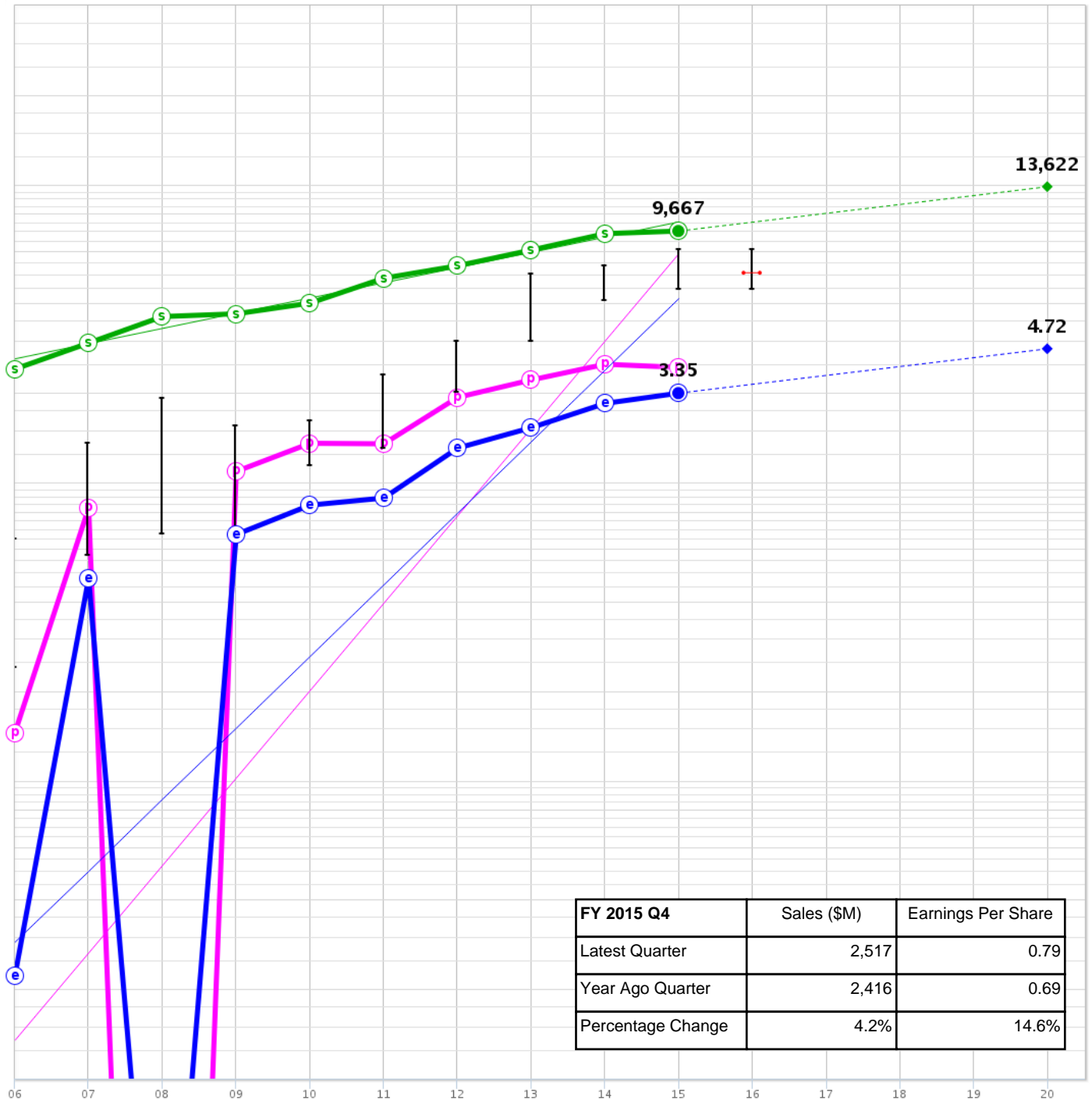

This shows how stock prices have fluctuated with earnings and dividends. It is building block for translating earnings into future stock prices.

4 EVALUATING RISK and REWARD over the next 5 years

Assuming one recession and one business boom every 5 years, calculations are made of how high and how low the stock might sell. The upside-downside ratio is the key to evaluating risk and reward.

A HIGH PRICE - NEXT 5 YEARS

Avg. High P/E 24.9 X Estimate High Earnings/Share 4.72 = Forecasted High Price \$ 117.5

B LOW PRICE - NEXT 5 YEARS

(a) Avg. Low P/E 21.3 X Estimate Low Earnings/Share 3.35 = Forecasted Low Price \$ 71.4

(b) Avg. Low Price of Last 5 Years 49.8

(c) Recent Market Low Price 68.7

(d) Price Dividend Will Support $\frac{\text{Indicated Dividend}}{\text{High Yield}} = \frac{0.67}{0.90\%} = 74.6$

Selected Forecasted Low Price \$ 67.9

C ZONING using 25%-50%-25%

Forecasted High Price 117.5 Minus Forecasted Low Price 67.9 = 49.6 Range. 25% of Range 12.4

Buy Zone 67.9 to 80.3

Hold Zone 80.3 to 105.1

Sell Zone 105.1 to 117.5

Present Market Price of 84.89 is in the **HOLD** Zone

D UPSIDE DOWNSIDE RATIO (POTENTIAL GAIN VS. RISK OR LOSS)

$\frac{\text{High Price} - \text{Present Price}}{\text{Present Price} - \text{Low Price}} = \frac{117.5 - 84.89}{84.89 - 67.9} = \frac{32.62}{16.99} = 1.9$ To 1

E PRICE TARGET (Note: This shows the potential market price appreciation over the next five years in simple interest terms.)

$\frac{\text{High Price} - \text{Closing Price}}{\text{Closing Price}} = \frac{117.5 - 84.89}{84.89} = 1.3842$ X 100 = 138.42 - 100 = 38.4 % Appreciation

5 5-YEAR POTENTIAL

This combines price appreciation with dividend yield to get an estimate of total return. It provides a standard for comparing income and growth stocks.

A $\frac{\text{Indicated Annual Dividend}}{\text{Closing Price}} = \frac{0.67}{84.89} = 0.0090 = 0.9\%$ Current Yield

B AVERAGE YIELD - USING FORECAST HIGH P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast High PE}} = \frac{11.3\%}{24.90} = 0.5\%$

AVERAGE YIELD - USING FORECAST AVERAGE P/E

$\frac{\text{Avg. \% Payout}}{\text{Forecast Average PE}} = \frac{11.3\%}{23.10} = 0.5\%$

C COMPOUND ANNUAL RETURN - USING FORECAST HIGH P/E

Annualized Appreciation 6.7 %
Average Yield 0.5 %
